# **PRIVACY POLICY**

The following privacy policy outlines how MYD Consulting Engineers (**MYD**) collects, uses and manages personal information about individuals.

MYD understands the importance of personal privacy and is committed to respecting the privacy of individuals and the security of all the personal information that MYD collects or receives. ## What are the types of information collected?

MYD may collect and hold the following types of personal information about an individual in order to conduct its functions and activities:

- name;
- date of birth;
- gender;
- business or home address;
- contact details;
- occupation;
- professional qualifications and experience;
- employer;
- financial information; and
- MYD internet webpages accessed.

#### How is personal information collected and held?

Personal information about individuals may be collected from the following persons or entities:

- directly from the individual;
- the individual's agents or representatives;
- third parties with express or implicit authority to provide or disclose personal information about the individual;

- credit reporting bodies;
- law enforcement; and
- statutory bodies.

Personal information may be collected in the following ways:

- in person;
- in writing;
- over the telephone;
- online; and
- by other electronic means.

Such personal information may be held by MYD and/or its agents or third party suppliers, electronically or on written paper records.

## What is the purpose of collecting such personal information?

Personal information collected and held, may be used or disclosed by MYD for the following purposes:

- conducting its business activities;
- compliance with legal or regulatory requirements;
- recruitment and employment;
- promotion of MYD's services or business;
- performance of MYD's professional services and duties;
- assessment of prospective clients and projects;
- responding to complaints, disputes or claims;
- undertaking of research relating to MYD's professional services; and
- passing on of information MYD's related companies, government or credit agencies, and legal and professional service providers where required or appropriate.

MYD only holds or collects data for the above mentioned lawful purposes and subject always to this privacy policy and the Laws of Australia.

### **Security and MYD's Websites**

MYD takes reasonable security measures in the protection of personal information, however unauthorised access to MYD's websites and data remains a possibility. MYD will not take responsibility for any breach of its security measures from anyone outside of MYD's control.
